LIABILITY RELEASE FORM FOR HILLSBORO CHRISTIAN CAMP 2018

In consideration for being accepted or permitted to participate by Hillsboro in Hillsboro Christian Camp, we (I) being 21 years of age or older, do for ourselves (myself) and for and on behalf of our (my) child-participant who is not yet 21 years old, do hereby release, forever discharge, and agree to hold harmless HYG and Hillsboro, the directors thereof and the adult chaperones of Hillsboro Christian Camp, from any and all liability, claims or demands for personal injury, sickness or death, as well as property damage and expenses of any nature whatsoever which may be incurred by the undersigned and/or the child-participant while said child is participating in Hillsboro Christian Camp.

Furthermore, we (I) hereby assume all risk of personal injury, sickness and death, damage and expense as a result of our (my) child-participant's involvement in Hillsboro Christian Camp.

Furthermore, HYG and Hillsboro acting by and through its employees or adult chaperones are hereby granted authority and permission to furnish any necessary transportation, food and lodging for our (my) child-participants in connection with Hillsboro Christian Camp.

The undersigned further hereby agree to hold harmless and indemnify HYG, Hillsboro, its directors, and the adult chaperones of the Hillsboro Christian Camp for any purported liability sustained as the result of the negligent, willful, or intentional acts of our (my) child-participant, including expenses incurred attendant thereto.
